**THIS MOTION**, made by the moving party, Catalyst Wealth Management Media Fund 1, LLC, (“**Catalyst**”) and the Ad-Hoc Group of creditors represented by Tyr LLP, for an Order pursuant to section 163(2) of the *Bankruptcy and Insolvency Act*, as amended (“**BIA**”), for the examination of Adam Davids of Adam Davids & Associates Consulting Inc. (“**ADAC**”) by the moving party and for the production by ADAC of any and all books, records, documents, correspondence, or papers in his possession or control in any capacity relating to Creative Wealth Media Finance Corp in advance of that examination, was heard this day at 330 University Avenue, Toronto, Ontario M5G 1R8.

**ON READING** the affidavit of Jeffrey W Krol, sworn February 22, 2024, and the affidavit of Arif Dhanani, affirmed February 21, 2024, and on hearing the submissions of counsel for the moving parties and counsel for TDB Advisory Inc., in its capacity as the trustee in the bankruptcy of the bankrupt, and upon being advised that Adam Davids with served with the motion materials as appears from the affidavit of service of Jenny Chen affirmed March 11, 2024,

1. **THIS COURT ORDERS** that the time for service of this motion is hereby abridged and validated so that this Motion is properly returnable today and hereby the requirement for any further service is dispensed with.

2. **THIS COURT ORDERS** that Adam Davids of ADC shall attend at an examination to be conducted by counsel for the moving parties at a time and place to be agreed with Mr. Davids provided that such examination shall take place no later than March 25, 2024, unless agreed to by counsel for Catalyst. For greater certainty, the trustee and its counsel may, but is not required to, also examine Mr. Davids at that examination pursuant to its powers under section 163(1) of the BIA.

3. **THIS COURT ORDERS** that within three (3) business days of the date of service of this Order on ADAC, or by such other time as may be agreed between ADAC and counsel to the moving parties, ADAC shall produce any and all books, records, documents, correspondence, or papers in his possession or control in any capacity relating to Creative Wealth Media Finance Corp. to counsel to the moving parties, including but not limited to relating to the following productions:

(a) Fables;

- (b) Hailey and the Hero Heart;
- (c) Gossamer;
- (d) Bubble's Hotel;
- (e) Robin Hood;
- (f) Ghostbusters;
- (g) Monkey Man;
- (h) Young Bear Grylls;
- (i) Playground LA;
- (j) Pathway;
- (k) Shadowplay;
- (l) National Anthem (aka Americana); and
- (m) Call My Agent.

The moving parties shall pay for the reasonable and documented disbursements and expenses incurred by ADAC in complying with this Order.

4. **THIS COURT ORDERS** that any interested party may apply to this Court to vary or amend this Order on not less than seven (7) days' notice to the moving parties and to any other party likely to be affected by the order sought or upon such other notice, if any, as this Court may order.

5. **THIS COURT ORDERS** that this Order may be served on Mr. Davids and ADAC by email at adam@adamdavids.com and that such service shall be valid and effective service. Subject to Rule 17.05 this Order shall constitute an order for substituted service pursuant to Rule 16.04 of the Rules of Civil Procedure.

6. **THIS COURT ORDERS** that the Registrar shall issue a summons to Adam Davids further to this Order.
